# Aim

Parents fully understand fee payment procedures and requirements and pay their childcare fees on time.

# Implementation

### Enrolment

- Upon enrolment families must pay a security deposit of two week's full fees. This bond is equivalent to the current daily fee x number of enrolled days per fortnight. Any bond owing when a child leaves the service will be refunded within 4 weeks of the child's last week of attendance being submitted to CCMS.
- The security bond which is indicated as 'BOND' is payable on enrolment and is nonrefundable if you cancel care before the start date.
- When extra permanent days are booked, a holding deposit/Bond adjustment is applied to your account. This will be reflected on your account.
- N.B. The holding deposit/bond adjustment is non-refundable if you change your mind before the organised start date.

### Fees

Our childcare fees are outlined in our fee schedule which is available from our office/administration are. Please note our fees may change from time to time. Fees must be paid on time and:

- weekly, fortnightly or monthly by direct deposit, eft.
- Please let us know what your pay cycle will be to avoid late fee's being added to your account.
- for every day that your child is enrolled at the service. This includes sick days, family holidays and public holidays but excludes periods when the service is closed including over the Christmas and New Year break period.
- Any extra days that you have booked will be charged for. These additional days cannot be compensated for normal booked days not used. If your child is absent on any booked day charges apply.
- Are to be paid ON TIME

### **Child Care Subsidy**

Child Care Subsidy is available to all families who are Australian Residents if the child meets immunisation requirements and parents meet eligibility requirements. Entitlement is determined by

an activity test which determines the number of hours of subsidised care to which families are entitled.

Hours of activity per fortnight	Maximum number of hours of subsidy per fortnight
8 hours to 16 hours	36 hours
More than 16 hours to 48 hours	72 hours
More than 48 hours	100 hours

A broad range of activities meet the activity test requirements, including paid work, selfemployment, unpaid work in a family business, active job hunting, volunteering or studying. You can also include reasonable travel time to and from a place of activity to the centre. In two parent families, both parents must meet the activity test, and subsidy hours are calculated on the lower number where parents have different levels of activity.

#### There are exemptions for parents who legitimately cannot meet the activity test requirements.

Exemptions	Number of hours of subsidy per fortnight
Families do not meet activity test and have low income eg	24 hours
combined annual income less than \$66,958 2108/2019 year	
Families do not meet activity test, child attends centre-based service	36 hours
with appropriate preschool program, and will attend school	
following year	

The percentage of subsidy a family receives is based on their estimated combined annual income. All families wishing to access Child Care Subsidy need to complete an online Child Care Subsidy assessment through their myGov account. Assessment asks families to provide information about their expected combined family income, activity level of parents and types of childcare service being used.

The Additional Child Care Subsidy may be available to help support:

- families needing help to support their children's safety and wellbeing
- grandparents on income support who are primary child-carers
- families in temporary financial hardship
- families moving to work from income support

Families can claim Child Care Subsidy or Additional Child Care Subsidy online by signing into their myGov and completing a Child Care Subsidy claim. If eligible, the Subsidy will be paid directly to the service on families' behalf and we will reduce the fees owed. This can occur after our service enters families' enrolment information online, and families confirm their enrolment information through their myGov account. Until Child Care Subsidy details are available, families will need to pay full fees.

Families are entitled to receive Child Care Subsidy for up to 42 days where their child is absent, for example due to illness, public holidays and parental leave. Evidence to support these absences is not required. Additional absence days may be available if they meet the situations outlined in the Family Assistance Law and there is evidence to support these.

#### **Statements of Account**

We will issue weekly Statements via the Xap Smile App, which include child/children's full name/s, date of care, date of payment, daily and weekly hours of care, absences, hourly fees and hourly and daily fee totals and the number of hours fees were reduced (eg by Child Care Subsidy) and total reduction amount. (Parents' My Gov accounts will also have how much care families have received and how much Child Care Subsidy has been paid.)

#### Invoices

Invoices for fees payable in a period will be issued every week. If families pay more than the fee amount required at the time, change will not be given but will be credited to the family's account.

#### Receipts

Receipts for payments made will be provided via the Xap Smile App.

#### Late Fees

Families who do not collect their child before we normally close for the day may be charged a late fee of \$15 for every 10 minutes or part thereof, they arrive past our closing time. This fee covers the cost of employing the staff required to supervise a child outside our operating hours. It may be waived at the discretion of the Nominated Supervisor.

#### Termination

Should you wish to end your child's place at the service, or should management make the decision to terminate your child's place, 2 weeks written notice is required from the ending/terminating party. If you do not provide this notice, you will be charged 2 weeks fees. Children must also be signed in and out by parents/guardians on the last scheduled day of their attendance for the Child Care Subsidy to apply. If this does not occur families are required to pay full fees.

#### **Overdue Fees**

The Administration/Finance Officer will issue a **Friendly Fee Reminder** letter to any family who is two (2) weeks late paying their fees. **If families are having difficulty making fee payments, they should immediately speak with the** Nominated Supervisor, Assistant Director or Administration/Finance Officer to discuss fee payment arrangements. Information provided by families will be treated as strictly private and confidential.

In cases of non-payment of fees, where the service is unable to contact families about the debt, or families do not meet agreed arrangements for repayment of the debt and ongoing payment of fees:

- bond payments will be applied to outstanding debt amounts and
- the Nominated Supervisor may immediately suspend or terminate the child's place at the service. Families will be advised of this action in writing.

Where families do not meet agreed payment plans, and an outstanding debt remains, the Nominated Supervisor may use their discretion to engage a third-party agency to recover the outstanding amount. The cost of this action may be added to the debt owed.

Fees of **\$10.00 a day** will apply to accounts which are 6 weeks + overdue. This fee will continue to be added each week until the account has been paid.
